備註：一、依護照條例第 18 條第 1 款規定，申請人有冒用身分，申請資料虛偽不實，或以不法取得、偽造、變造之證件申請之情形者，主管機關或駐外館處應不予核發護照。二、護照條例第 24 條第 3 項規定「將護照交付他人或謊報遺失以供他人冒名使用者，處五年以下有期徒刑、拘役或科或併科新臺幣十萬元以下罰金。」

**Notes: 1. In accordance with Article 18, Paragraph 1 of the Passport Act**, if an applicant assumes a false identity, provides false information on the application, or applies using documents that are illegally obtained, forged, or altered, the competent authority or overseas mission shall not issue a passport. **2. Article 24, Paragraph 3 of the Passport Act states:** "Any person who delivers a passport to another person or falsely reports a passport as lost to facilitate another's use of a false identity shall be sentenced to imprisonment for not more than five years, detention, and/or a fine of not more than NT\$100,000."
