# Visitor visa applicants (over 90 and under 180 days of stay)

#### 1. Persons under 18 years of age travelling without statutory representative

- a passport valid at least 6 months after entering Taiwan
- a copy of passport page with biometric data
- 2 passport size color photographs
- a duly filled "Visa Application Form" original with signature is required
- documents proving the purpose of stay (e.g. a copy of invitation letter, accommodation confirmation, etc.)
- a copy of bank statement of the applicant's or parents' account with the minimum balance in the amount of  $\[ \in \] 1,000$
- a copy of <u>return</u> air ticket reservation or air ticket reservation <u>to another destination</u>
- statutory representative's approving statement with the travelling and a copy of identity card of the statutory representative

### 2. Adults travelling for **tourism purpose**

- a passport valid at least 6 months after entering Taiwan
- a copy of passport page with biometric data
- 2 passport size color photographs
- a duly filled "Visa Application Form" original with signature is required
- documents proving the purpose of stay (e.g. a copy of invitation letter, accommodation confirmation, etc.)
- a copy of bank statement of the applicant's or parents' account with the minimum balance in the amount of €1,000
- a copy of <u>return</u> air ticket reservation or air ticket reservation <u>to another destination</u>

## 3. Adults travelling for **business trip**

- a passport valid at least 6 months after entering Taiwan
- a copy of passport page with biometric data
- 2 passport size color photographs
- a duly filled "Visa Application Form" original with signature is required
- documents proving the purpose of stay (a copy of invitation letter with a copy of employment confirmation from the employer within the territory of the Slovak Republic / Romania pursuant to the nationality of the applicant or a copy of trade license in case of self-employed person)
- a copy of bank statement of the applicant's or parents' account with the minimum balance in the amount of €1,000
- a copy of <u>return</u> air ticket reservation or air ticket reservation <u>to another destination</u>

## 4. Adults travelling for **employment purpose**

- a passport valid at least 6 months after entering Taiwan
- a copy of passport page with biometric data
- 2 passport size color photographs
- a duly filled "Visa Application Form" original with signature is required

- documents proving the purpose of stay (a copy of invitation letter with a copy of employment confirmation form the employer within the territory of the Slovak Republic / Romania pursuant to the nationality of the applicant or a copy of trade license in the case of self-employed person)
- a copy of Working Permit issued by competent authorities in Taiwan
- a copy of bank statement of the applicant's or parents' account with the minimum balance in the amount of €1,000
- a copy of <u>return</u> air ticket reservation or air ticket reservation <u>to another destination</u>
- It is possible to apply for a Working Permit directly in Taiwan as well. In this case, the applicant applies for issuing visitor visa for purpose other than the purpose of employment. Taiwanese partnership company of the Slovak / Romanian employer (pursuant to the nationality of the applicant) shall apply for issuing the Working Permit within 30 days starting from entering Taiwan; it is forbidden for the applicant to work until this time. After the issuing of the Working Permit, the Consular Department of the Taiwanese Ministry of Foreign Affairs shall change the purpose of the visitor visa, or prolong the stay in Taiwan.

#### 5. Adults travelling for **modelling purpose**

- a passport valid at least 6 months after entering Taiwan
- a copy of passport page with biometric data
- 2 passport size color photographs
- a duly filled "Visa Application Form" original with signature is required
- documents proving the purpose of stay (e.g. a copy of invitation letter, accommodation confirmation, etc.)
- a copy of Working Permit issued competent authorities in Taiwan
- a copy of employment contracts with Slovak / Romanian agency pursuant to the nationality of the applicant and a copy of contract with agency in Taiwan
- a copy of bank statement of the applicant's or parents' account with the minimum balance in the amount of €1,000
- a copy of <u>return</u> air ticket reservation or air ticket reservation <u>to another destination</u>
  - It is **not necessary** to apply for visitor visa **in person**.
  - Visa collection is possible **in person or by a representative** (without a POA).
  - It is also possible to apply and collect visa by a **shipping company**, although personal application and collection is preferred.
    - In case of applying for visa by post office/shipping company, please attach the visa fee in cash (we require exact amount).
    - ➤ In case of using a shipping company (e.g. FedEx, TNT, DHL, etc.) for returning your documents, the applicant needs to enclose a self-addressed envelope for the return and original of duly filled and signed "Letter of Consent" available for download here: <a href="http://210.71.198.58/sk en/wp-content/uploads/sites/155/2015/09/n5.pdf">http://210.71.198.58/sk en/wp-content/uploads/sites/155/2015/09/n5.pdf</a>
    - > Starting from September 1, 2016, the applicant shall order the shipping service and pay the shipping fee themselves. Please note our Office will not handle ordering or payment for the shipment. We would like to inform you that in case of sending a shipment outside Slovakia, majority of shipping companies accept import shipments only from registered artificial persons with established accounts in the respective country of delivery.
    - ➤ The Office will not take the responsibility for any postal delays or loss.
    - For Romanian citizens it is also possible to apply for visa at our sister office in Budapest (Taipei Representative Office, Budapest <a href="https://www.roc-taiwan.org/hu">www.roc-taiwan.org/hu</a>).
  - Issuing fee is €43 (within 3 working days) for <u>single entry</u> or €86 (within 3 working days) for <u>multiple entry</u>. There is a 50% surcharge in addition to the basic fee for the express issuing within 24 hours.
