

僑務委員會「2025 年臺灣航太暨無人機產業邀訪團」

活動介紹

一、活動目的：

隨著各國政府對國防安全的高度重視，以及軍、民用市場對無人機需求的持續增長，航太國防與無人機產業領域正迎來前所未有之發展機遇。臺灣位於亞太樞紐位置，擁有世界領先的半導體及 AI 產業研發實力，並具備卓越的製造技術、品質管理及高度創新能力，在全球市場極具競爭力。為加強全球僑臺商與國內政府部門及產業界的交流合作，推動資源互補與技術對接，協助僑臺商提升競爭力，促進臺灣優勢產業與技術向國際拓展，邀請對航太暨無人機相關領域有興趣或已有經營基礎的僑臺商返臺交流，共創產業合作商機，助益國內經濟發展及臺灣技術實力的國際化布局。

二、活動時間：

114 年 9 月 14 日（星期日）至 9 月 18 日（星期四），共 5 天 4 夜。

三、參加對象：

具備中文溝通能力，於僑居地經營相關產業或有意投資航太暨無人機產業之僑臺商，並能協助將臺灣航太暨無人機相關產業拓展至海外市場者，並以近 2 年未曾參加本會經貿研習、參訪活動者優先錄取。

四、遴薦方式：

- (一)由各駐外館處、本會海外華僑文教服務中心或駐外僑務人員辦理遴薦，並送本會審核。
- (二)預計於 114 年 7 月函知各駐外館處及海外華僑文教服務中心本會審核結果，並轉知通過審核者至本會「僑務活動報名系統」依限完成線上資料登錄事宜。

五、活動內容：

全程計 5 天 4 夜，包括拜會我國航太暨無人機產業相關政府機關與機構、產業趨勢專題演講、參觀 2025 年「臺北國際航太暨國防工業展」、「臺灣國際無人機暨無人載具展」、企業參訪與交流、商機媒合洽談會及綜合座談等。（請參閱預定日程表草案，確切日程表於本會審核通過後另行通知，本會保留依實際執行情形調整之權利）

七、注意事項：

- (一)同一家庭或同一公司限 1 人參加；為維護本邀訪團紀律，不得攜伴（包含眷屬、助理）隨同參加本活動。
- (二)經審核通過團員於接獲通知並依本會規定至「僑務委員會活動報名系統」登錄個人資料及「向承辦單位確認報到相關事宜」後，始取得參加資格。
- (三)本團日程緊湊，請衡量自身健康及體力狀況，以免活動期間不堪負荷，致影響活動流程；為避免浪費資源，本活動須全程參與，除有特殊事由經本會同意者外，不得擅自脫隊行動，未能全程參與者請勿參團。
- (四)請於接獲確認審核通過通知後，再購買往返機票，另報到前或活動期間倘有不適症狀，請主動告知本會或承辦單位人員並停止參團。

OCAC 2025 Taiwan Aerospace and Drone Industry Visiting Program for Overseas Compatriot Entrepreneurs – Program Overview

I. Purpose and Objectives:

With increasing global emphasis on national defense and a growing demand for drones in both military and civilian markets, the aerospace, defense, and drone industries are witnessing unprecedented opportunities for development. Positioned at the strategic hub of the Asia-Pacific region, Taiwan boasts world-leading semiconductor and AI research and development capabilities, along with exceptional manufacturing technology, quality management, and innovation—making it highly competitive in the global market.

To strengthen ties between overseas compatriot entrepreneurs and relevant government agencies and domestic industries, this program aims to foster collaboration, facilitate resource integration and technological alignment, and enhance the global competitiveness of overseas compatriot enterprises. Entrepreneurs engaged in or interested in the aerospace and drone sectors are cordially invited to return to Taiwan to explore industrial cooperation opportunities, with a view to contributing to Taiwan's economic development and expanding its technological presence on the global stage.

II. Program Date:

September 14 (Sunday) to September 18 (Thursday), 2025 — total 5 days and 4 nights.

III. Eligibility for Registration:

Overseas compatriot entrepreneurs with Mandarin communicative skills who are currently operating or interested in investing in aerospace and drone industries, and who can assist Taiwanese aerospace and drone industries in expanding into overseas markets. Priority will be given to applicants who have not participated in any OCAC economic and trade workshops or visiting delegations in the past two years.

IV. Selection Information:

- A. Candidates will be recommended by the ROC (Taiwan) embassies and missions, OCAC Culture Centers, or stationed personnel, and further reviewed and approved by the OCAC.
- B. The results are expected to be issued via official letter in July 2025 to the local overseas missions and Culture Centers, who will notify the qualifiers to

log in to complete personal information registration through the OCAC Overseas Compatriot Affairs Activity Registration System by the designated deadline.

V. Program Agenda:

This five-day, four-night program features visits to relevant government agencies and institutions involved in Taiwan's aerospace and drone industries, keynote speeches on industry trends, guided tours of the 2025 Taipei Aerospace & Defense Technology Exhibition and the Taiwan International Drone and Unmanned Vehicle Expo, as well as corporate visits, business matchmaking sessions, and panel discussions.

VI. Program Fees:

A. Expenses to be covered by OCAC:

Program attendees' lunches and dinners, accommodations, group transportation, visitations, insurance, and venue expenses for the duration of the program.

B. Expenses to be covered by the program attendees:

1. Round-trip airfare and related travel expenses between location of residence and Taiwan, transportation to and from the check-in location, and other personal expenses.
2. During the program, double occupancy rooms will be arranged. If any

participant requires a single occupancy room, he or she will need to cover the difference; if any participant need to check in early or check out late, he or she should mention it in advance, and room will be arranged depend on the accommodation situation of the hotel. The relevant expenses will be borne by the participant.

3. During the program, attendees will be covered by a NT\$2,000,000 travel safety or accident insurance, with an additional 10% accident medical coverage. If attendees consider this coverage insufficient, they may choose to increase the coverage limit at their own discretion. If the attendee contracts any disease, falls ill, and requires medical treatment while in Taiwan, he or she is responsible for all related medical expenses.

VII. Important Note:

- A. Registration is limited to only 1 person from each household or company; to retain the integrity of this program, companions (including family members and assistants) are not permitted.
- B. Applicants will obtain program eligibility only after registering personal information on the “OCAC Overseas Compatriot Affairs Activity Registration System” and completing the confirmation of check-in procedures with the organizer.
- C. The schedule of this program is intensive. Attendees are advised to consider their own health and physical condition to avoid overexertion during the program, which could impact the flow of activities. To avoid wasting resources, full participation throughout the program is required. Unless with special permission granted by the OCAC, attendees should not leave the program without authorization. Those who cannot participate for the entire duration should refrain from participating.
- D. Applicants are advised to refrain from purchasing air travel tickets until they have received official confirmation of acceptance. If the attendee has any symptoms of discomfort before check-in or during the program, please inform the OCAC or staff members immediately and cease participation in the program.
