電子簽證係由中華民國駐外館處核發，准許外籍人士入境臺灣及在境內旅遊的官方文件。申請人將在填寫必要個人基本資訊、刷卡付費（MasterCard或Visa）及查核身分資格無虞後，取得電子簽證。

電子簽證通過審查後，外交部領事事務局簽證核發系統將自動寄發簽證許可通知至申請人指定的電郵信箱，申請人可利用該通知內含的網頁連結下載及列印電子簽證，以持憑入境。

誰具備申請電子簽證的資格？

下列國家的國民，符合必要條件，可申請電子簽證：貝里斯、汶萊、布吉納法索、哥倫比亞、多明尼加、厄瓜多、薩爾瓦多、瓜地馬拉、海地、宏都拉斯、吉里巴斯、馬其頓、馬紹爾群島、諾魯、尼加拉瓜、帛琉、巴拿馬、巴拉圭、秘魯、聖克里斯多福、聖露西亞、聖文森、聖多美普林西比、索羅門群島、史瓦濟蘭、土耳其、吐瓦魯。

應邀來我國參加由中央政府機關或非政府組織主辦、協辦或贊助之國際會議或活動的外籍人士。

哪種護照可申請電子簽證？

所持護照效期須在6個月以上；普通、公務及外交等正式護照均適用，但不包含緊急、臨時、其他非正式護照或旅行文件。

電子簽證之訪問目的？

請注意，電子簽證只許可作為觀光、洽商、探親及應邀出席在臺舉辦的國際會議及運動賽事等用途。其他種類的簽證（如工作、就學、依親、研習中文等）必須向中華民國的駐外館處提出申請。

電子簽證的效期及停留期限？

電子簽證效期從許可通知書所載明的日期開始生效，效期一律為三個月、單次入境、最長停留期限30天，不可延期。

電子簽證的申請費用？

除因互惠及另有規定外，電子簽證申請規費為新臺幣1,600元。連同您使用信用卡刷卡繳付的銀行手續費新臺幣32元，總計1,632元。

An eVisa is an official document issued electronically by ROC overseas missions that allows foreign nationals to enter and travel in Taiwan. To obtain an eVisa, applicants must submit relevant personal information and pay the required fee by credit card (MasterCard or Visa). The eVisa will be issued after the submitted information has been assessed and found to meet relevant criteria.

When an eVisa application has been approved, the visa issuance system of the Bureau of Consular Affairs (BOCA) of the ROC Ministry of Foreign Affairs will automatically send a notice to the applicant's designated email account containing a webpage link to download and print the eVisa.

Who is eligible for an eVisa?

Nationals of the following countries are eligible for an eVisa when they meet relevant criteria: Belize, Brunei, Burkina Faso, Colombia, Dominican Republic, Ecuador, El Salvador, Guatemala, Haiti, Honduras, Kiribati, Macedonia, Marshall Islands, Nauru, Nicaragua, Palau, Panama, Paraguay, Peru, Saint Kitts and Nevis, Saint Lucia, Saint Vincent and the Grenadines, Sao Tome and Principe, Solomon Islands, Swaziland, Turkey, and Tuvalu.

Furthermore, foreign nationals who have been invited to attend international conferences or activities in Taiwan—organized, co-organized, or sponsored by central government agencies or certain nongovernmental organizations—are also eligible for an eVisa.

What conditions must the applicant's passport meet for an eVisa?

An eVisa applicant's passport must be an ordinary, official, or diplomatic passport with remaining validity of at least six months. Emergency, temporary, and other informal passports or travel documents cannot be used to apply for an eVisa.

What are eVisa holders' purposes of visit?

Please note that eVisas are only granted for tourism and business purposes, as well as for visiting relatives and attending international conferences or sporting events in Taiwan. If you intend to travel to Taiwan for other purposes—such as employment, study, residence with family, or Mandarin language courses—you must submit an application for a suitable type of visa at an ROC overseas mission.

What is the validity of an eVisa?

The validity of an eVisa is three months starting from the issue date. The eVisa is a single-entry visa, and the maximum duration of stay in Taiwan is 30 days, which cannot be extended.

What is the application fee for an eVisa?

Unless reciprocity is applicable or stipulated otherwise, the application fee for an eVisa is NT\$1,600. Including the NT\$32 processing fee for the online credit card payment, the total amount is NT\$1,632.
