1. 申請注意事項 Application Instructions

1.1. 修業年限 Program Duration

學士班修業年限為 4-6 年；碩士班修業年限為 1-4 年；博士班則為 2-7 年。

Once being officially enrolled, students shall complete their undergraduate programs within 4 to 6 years. Master's programs shall be completed within 1 to 4 years and Ph.D. programs within 2 to 7 years.

1.2. 報名繳件日期 Application Period

本年度外國學生申請入學分為二梯次，第一梯次未足額錄取之名額得流用至第二梯次。
NCCU admission for Fall 2024 is divided into 2 rounds. If the admission quota for the first round is not fully met, the remaining will be allocated to the second round.

線上報名日期：2024 年 2 月 15 日(星期四)至 2024 年 3 月 21 日(星期四)下午 5 點止 (臺灣時間)，逾期不受理。

Application period: **Thursday, February 15, 2024 – 5:00 pm, Thursday, March 21, 2024** (Taiwan time; GMT +8). Late application will not be processed.

1.3. 報名方式 Application Procedure

一、繳交報名費 Payment

(1) 申請費 Application Fee

每一申請件新臺幣 1,600 元或美金 60 元。

NT\$ 1,600 / US\$ 60 per application.

※申請費一經繳交，恕不退還，包含欲取消申請件、申請資格不符、逾期送件、溢繳、重複繳費、誤繳等。

The application fee is non-refundable, including the withdrawal of application, failure to meet requirements, mistake in the payment, duplicate payment, etc.

二、上傳申請資料 Uploading documents

(一)注意事項 Please pay close attention to the following:

- (1) 所有申請人需至線上報名系統上傳應繳資料，請務必審慎檢視上傳資料正確無誤後，點選「確認送出」鍵完成申請，本校將以系統中申請人最後確認送出的檔案為準，日後不得以任何理由要求修改或補件。

All applicants need to upload required documents to the online application system.

Applicants will be asked to confirm the submission of the documents. Please go through the documents carefully before confirming the submission. NCCU will only process the final and confirmed documents. Applicants may not change the submitted documents for any reason once they have confirmed submission.

- (2) 申請資料請以 PDF 檔案上傳，請依各項文件欄位逐一上傳，每一文件項目僅可上傳單一檔案。申請人若單一項目有多個電子檔，請自行合併成一個檔案後再上傳，並以 5 MB 為限。每一系所學程的審查檔案，最多 20 MB。

All required documents shall be uploaded in PDF files. Each document shall not be larger than 5 MB, and documents for each department/graduate institute shall not be more than 20 MB. Applicants are to upload each of the documents to its respective field. Only one file for each field is accepted. Thus, if applicants have multiple files for a particular field, applicants will need to combine them into one file before uploading.

- (3) 未依申請相關規定完成之申請者其申請將視同無效，本校不予受理，其責任由申請者自行負責。

If the applicants fail to comply with each application requirement or regulation, their applications will be considered invalid, and the applicants will be held solely responsible.



(二) 應繳文件 Required documents

- (1) **申請費收據**：每一申請件新臺幣 1,600 元或美金 60 元。如由銀行電匯入本校帳戶或至本校出納組繳費，請上傳銀行電匯收據或本校收據。透過線上信用卡繳款者無須另附單據。

Application fee receipt: The fee is NT\$ 1,600 / US\$ 60 per application. If the application fee is remitted to the university account or paid directly at the NCCU Cashier Section, please upload the Telegraphic Transfer receipt or the receipt from the NCCU Cashier Section. No receipt is needed if the transaction is done via online credit card payment.

- (2) **照片**：脫帽半身彩色大頭照，限以 JPG 格式上傳。

Photograph: a passport-size color headshot (without hat/headaddress/sunglasses). Please upload it in JPG format.

- (3) **申請表及具結書**：線上申請系統自動帶出，需線上簽名後上傳。

Application Form and Declaration: Both will be generated by the online application system. Please complete the online signature, download the application forms, and then upload them to the system.

- (4) **國籍證明文件 (護照)**。

Verification of nationality: Please upload the information page of your passport to the application system.

If applicable, NCCU may ask the applicant to provide the “Forfeited Nationality Permit Certificate” issued by Taiwan’s Ministry of the Interior, “Certificate of Entry and Exit Dates” issued by the National Immigration Agency, a signed “[Non-Household Registration Declaration](#)” or other official certificates.

- (5) **畢業證書或最高學歷證明文件(中、英文以外之語文，須加附經公證之中文或英文譯本)。**

One photocopy of the diploma of the highest academic degree obtained. If the original diploma is not issued in English or Chinese, an additional copy notarized and translated into English or Chinese must be submitted along with the original document.

※ 持大陸地區學士學位以上(含)者，另須繳交「學位證(明)書」。

Applicants with a bachelor’s degree or above from one of the institutions in Mainland China are required to submit a certificate of degree conferral.

※ 應屆畢業生申請時可不需繳交畢業證書，但請上傳由其學校出具的「預計畢業證明書(中文或英文)」。且畢業日期需登載於 113 年 8 月 31 日以前。

This year’s graduates do not need to submit their diploma when applying to NCCU, but they are required to submit an official certificate of expected graduation (in English or Chinese) issued by their school. In addition, the graduation date should be no later than



August 31, 2024.

(6) 歷年成績單(中、英文以外之語文，須加附經公證之中文或英文譯本)。

One complete academic transcript. If the original transcript is not issued in English or Chinese, an additional notarized copy translated into English or Chinese must be submitted along with the original document.

- ※ 學士班申請人應繳交高中(以上)歷年成績單、碩士班申請人應繳交學士(以上)歷年成績單、博士班申請人應繳交碩士(以上)歷年成績單。

Undergraduate program applicants should submit: Transcript from previous high school (or above); Master's program applicants: Transcript from previous bachelor's degree (or above); Ph.D. program applicants: Transcript from previous master's degree (or above)

- ※ 錄取生於辦理報到時，應依以下規定繳交經相關單位驗證之畢業證書、學位證書(適用於持大陸地區學士及以上學位者)及歷年成績單與其他相關學歷證明文件並辦理報到，始得註冊入學。

Admitted applicants can enroll only after they have submitted the photocopies of their diploma, certificate of degree conferral (applicable to applicants with a bachelor's degree or above from an institution in Mainland China, which is specifically recognized by the MOE) as well as their complete academic transcript and other relevant academic certificates. In addition, all of them must be verified by the related Offices according to the following regulations.

- 持國外學歷者，應依教育部『大學辦理國外學歷採認辦法』規定辦理。畢業證書及歷年成績單應經過學校所在地之台灣駐外單位或代表處驗證。如原始文件為中、英文以外之語文，其中文或英文譯本亦應經過台灣駐外單位或代表處驗證。Students whose degrees are conferred by foreign schools (excluding the schools in Hong Kong, Macau, and Mainland China) shall follow the “Regulations Regarding the Assessment and Recognition of Foreign Academic Credentials for Institutions of Higher Education.” The diplomas and the full academic transcripts are required to be verified by the Taiwan Overseas Representative Offices in the country where the degree-issuing school is located. If the original documents are not in Chinese or English, a Chinese or English translation verified by the Taiwan Overseas Representative Offices is also required.
- 持香港或澳門學歷者，應依『香港或澳門學歷檢覈及採認辦法』規定辦理。Students whose degrees are conferred by the prescribed schools in Hong Kong or Macau shall follow the “Academic Credential Verification and Accreditation Methods adopted in Hong Kong and Macao” for the requirements of relevant academic certificates.
- 持大陸地區學歷者，應依『大陸地區學歷採認辦法』規定辦理。Students whose degrees are conferred by the schools in Mainland China, which are specifically recognized by the MOE, shall follow the “The Regulations Governing the Accreditation of Schools in Mainland China” for the requirements of relevant academic certificates.

(7) 最近三個月內經由金融機構提出之中文或英文存款證明新臺幣 200,000 元以上 (美金 7,000)。



An official bank statement (in Chinese or English) that indicates an account balance of more than NTD\$ 200,000 (**USD\$ 7,000**). The statement has to be issued by a financial institution and cannot be older than 3 months at the time of the application.

If the statement is not in the name of the applicant himself/herself, a signed sponsorship letter (in Chinese or English) is required. In this sponsorship letter, the relationship between the sponsor and the applicant has to be stated and the support of the applicant's expenses during the applicant's study in Taiwan has to be guaranteed.

Students with full scholarship must provide proof of award.

※若存款證明之幣值非新臺幣或美金，申請人需自行於存款證明上註明匯率，並換算成相當於新臺幣或美金之總額。

If the currency of the bank statement is in neither NT dollars nor US dollars, applicants themselves shall convert the total amount into either NT or US dollars and write down the exchange rate on the bank statement.

(8) 各系所應繳交資料

Additional application materials required by the individual department or graduate institute (please refer to section 2 of this brochure, titled “Criteria of Each Department or Graduate Institute”)

Applicants with incomplete application documents or who have not followed the application procedure will be informed via e-mail to provide further documents.

(9) 語言能力要求 Language Proficiency Requirements

- 請繳交有效期間內之語言能力證明，檢定證書或成績到期日不可早於正取生線上報到截止日（2024年6月11日）。Please submit valid language proficiency certificate. The expired date of your language proficiency certificate should be later than the last day of confirming acceptance (June 11th, 2024).
- 如申請者未能於申請期間提交語言檢定證明，經錄取後應於入學前（2024年6月30日前）補交，否則將撤銷其入學資格。If the admitted applicants fail to submit certificate of language proficiency during the application period, they should submit the certificate before registration deadline (June 30th, 2024), or the admission will be revoked.
- 本校系所（學位學程）依授課語言分為華語文授課及英語文授課（含有足夠英語文授課課程可滿足畢業需求之系所）。各系所（學位學程）授課語言依簡章公告之。The departments and degree programs of the University are categorized into two types based on the language of instruction: Chinese-taught programs, English-taught programs (including programs that offer sufficient English-taught courses to fulfill graduation requirements). Applicants who meet the following criteria may provide relevant documents as alternatives to Chinese language test certificates:

If your native language is Chinese, please provide a personal statement describing your Chinese language background. This statement should explain your daily use of Chinese, your learning experience, and your proficiency in Chinese listening, speaking, reading, and writing.

If your previous degree programs were taught in Chinese, please provide proof of Chinese language instruction for that degree.

If you majored in Chinese for previous degree, please provide the graduation certificate or a certificate issued by the school.

三、確認送出申請 Application Submission

申請人須完成以下所有步驟後，才能點選「確認送出申請」。

Applicants must complete all the following steps in order to select “Confirm and Submit”

1. 填寫線上申請表

Fill out the application Form

2. 資料上傳

Upload all the required documents.

3. 未依規定於期限內線上送出申請，郵寄或親送紙本申請文件者，本校將不予受理。

If applicants fail to upload the documents onto the system before the deadline, or if they deliver the documents in person or by post, their applications will not be processed.

四、申請狀態查詢 Application Status

申請者可於完成報名一周後，逕至本校線上申請系統查詢申請進度，如身分及學歷符合外國學生申請資格，申請狀態則會顯示為通過初審，進入系所審查梯次。並可於 2024 年 4 月 9 日後查詢申請狀態。

Applicants can check their application status one week after document submission. If applicants are qualified as international students pursuant to the MOE Regulations Regarding “International Students Undertaking Study in Taiwan”, they will pass the initial review and enter the stage of admissions committee review. Applicants can check application results after April 9, 2024.

1.4. 申請資格 Eligibility

(1) 外國學生身分 Definition of International Students

外國學生定義如下：

International students are defined as follows:

The admissions committee is composed of the Vice President in charge of international affairs, the Dean of Academic Affairs, the Vice president for International Cooperation, the deans of relevant colleges, and the directors of relevant departments or programs. The committee is convened by the Vice President. Once the applicants pass the review, their admissions will be approved by the President, and they will be issued an admission letter, notifying them of their acceptance.

Moreover, those who withdraw or are dismissed from school in the Republic of China due to misbehavior, unacceptable academic performance or a conviction under Criminal Law may thereafter not apply again for admission under "Regulations Regarding International Students Undertaking Studies in Taiwan." Violation of the regulations, once confirmed, will result in the cancellation of an application for admission.

- (9) 考生對考試結果有疑義者，應於放榜後 14 日內，以書面載明下列各款，向本校國際合作事務處提出申訴：姓名、報考系所組別、住址、聯絡電話、申訴日期、敘明疑義之具體理由與佐證資料。

國合處應於受理後一個月內正式函復，並告知申訴人行政救濟程序，必要時得組成專案小組公正調查處理。考生對於招生委員會處理申訴之結果若有不服，得依法再提行政爭訟。

For any appeals regarding the admission results, applicants may submit a written statement to the Office of International Cooperation (OIC) within 14 days after the announcement of the admissions results. The written statement should include the following information: Name of the applicant, the department/program/graduate institute he/she applied to, Address, Phone Number, Date of Appeal, and a statement of specific reasons and supporting evidence for the doubt.

OIC should provide a formal response within one month of receiving the complaint and should form a task force for an impartial investigation if necessary. If students are unsatisfied with the outcome of the appeal to OIC, they may seek an administrative remedy in accordance with the law.
