- 二、申請人請每年檢送我國駐外單位驗證之申請書,由輔導會依申 請人國外銀行開戶資料,定期辦理俸金匯款作業。銀行名稱或 帳戶如有變動,請另檢送住在國銀行出具之銀行開戶證明(含 銀行名稱、地址、本人戶名、帳號)送驗;指定第三國銀行收 匯或使用共同帳號者,不予受理。
