In case of any misrepresentation, I am willing to bear any arising legal liability.

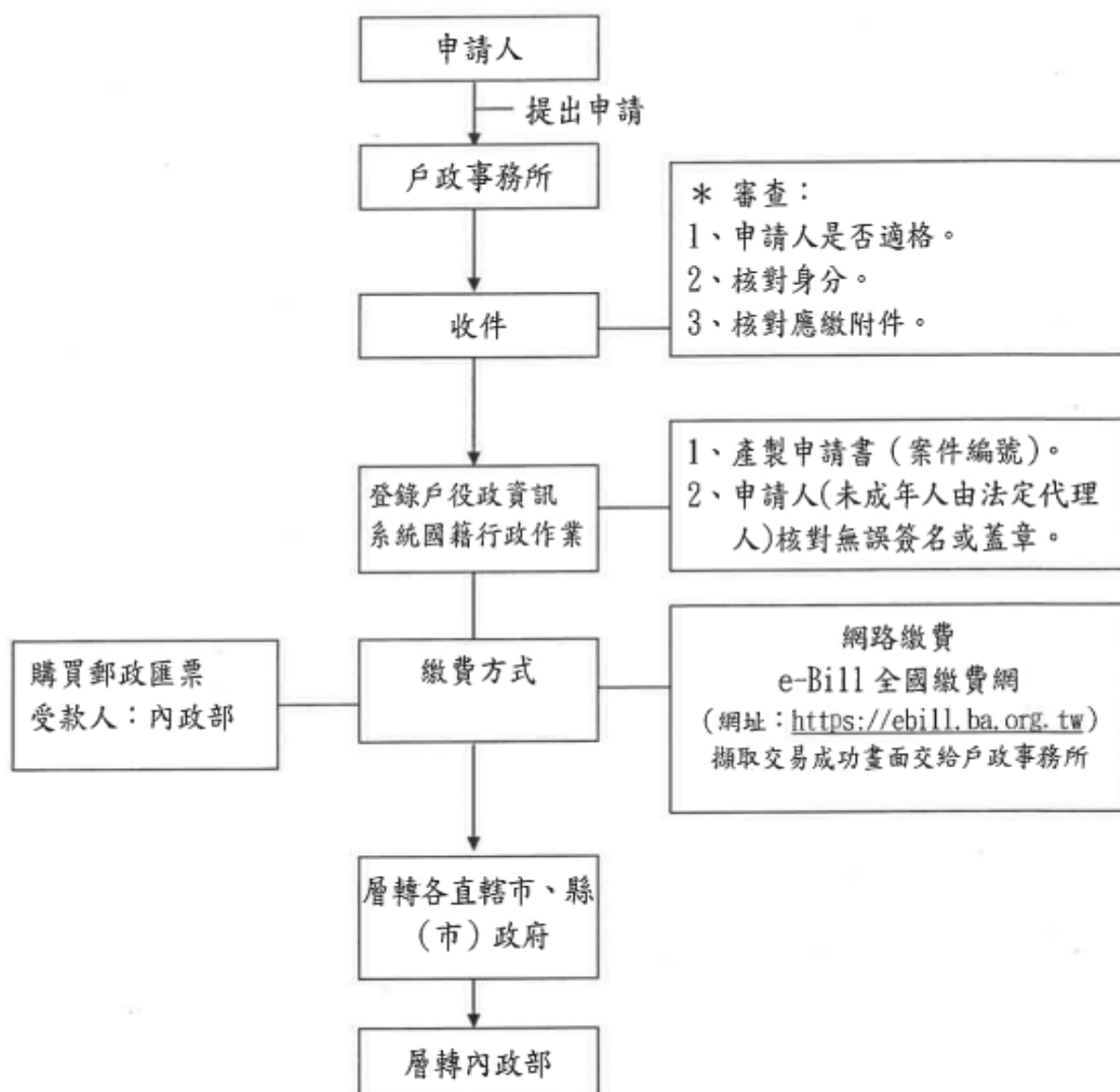
